## **Content and Aim**

GAO-S Graduate School is an interdisciplinary and international graduate school organized by Stockholm University (SU) in collaboration with Linnaeus University (LNU) and Lund University (LU) as well as PhD students from universities in Sweden and abroad (online). GAO-S targets PhD candidates and early career scholars whose research is based on digital archival sources in various languages and who engage with archives and repositories with a global or transnational dimension. As such, the two key aims of GAO-S, methodological development of work with digital archives and pedagogical development for undergraduate supervision, encourage a bottom-up dialogue between scholars and students in research institutions in and outside Sweden.

# 1. METHODOLOGICAL DEVELOPMENT

GAO-S will help to improve participants' work with (digital) sources of various genres, periods, and languages and offer an opportunity to systematically reflect on the technical, logistical, and epistemological challenges of specific source corpora. Building upon the special requirements of particular research fields, PhD candidates will be offered help in

identifying and choosing digital source material, and be encouraged to reflect on obstacles, identify chances, and work out solutions to methodological limitations.

In addition to introducing doctoral students to digital research practices, they will participate in discussions on the application and specific epistemological and institutional requirements. Participation of GAO-S will encounter a safe forum where they can improve their presentation, argumentation and networking skills as part of a global research environment.

Depending on the geographical, thematical and linguistic background of the participants, as well as the nature of their sources, PhD candidates will learn how to improve and systematize work with large digital data sets and improve their understanding of digital humanities including metadata and ethical aspects.

#### 2. PEDAGOGICAL DEVELOPMENT

The second aim of GAO-S is of pedagogical value and will include active work with Global Archives Online (GAO). GAO is a directory of open digital collections designed to identify and locate open resources for the study of global history with the ultimate aim of drafting a manual for future use in supervision and teaching (<a href="https://calb.ro/global-archive">https://calb.ro/global-archive</a>) As a vast and useful resource it can enrich teaching and essay writing in subjects such as trade, migration, colonialism, or diplomacy, but also in historical research in cultural and social history, local history, or microhistory. The pedagogical work with GAO aims to optimize its applicabitlity in undergraduate supervision and to sharpen it as a tool to approach novel topics with comparative, quantitative, and qualitative methods in line with the state-of-theart in both Digital History and Global Humanities. As tapping the full potential of GAO requires both a better knowledge of the database and the multifaceted opportunities for different target groups, GAO-S aims to provide a platform for a collaborative optimization of GAO, aiming, for instance at thematic categorization and the extension of keywords and tags informed by metadata and research requirements.

### Workshop 2 (webinar): 24 September, 13-16 (zoom)

This session will pick-up on the feedback from the workshop and address further challenges of digital archives for research projects in global history.

- (1) Hands-on GAO session: evaluation and SWOT-analysis: Participants will discuss the limits and possibilities of GAO
- (2) Work in regional and thematic focus groups

### Workshop 3 (webinar): 17 Oktober 2024, 12-15 (zoom)

- (1) This session introduces foundational principles of enriching and structuring data in databases and designing data models for research projects. It also presents Tropy as an indispensable tool for multi-archival research and discusses the ethical dilemmas of globally accessible archives. Participants will be required to precirculate reflection papers on their concrete experiences with digital archival work, and the roles digital archives play for their PhD projects.

### Workshop 4 (webinar): 28 Oktober 2024, 12-15 (zoom)

This session will focus on undergraduate and graduate supervision based on digital archival sources and GAO in particular. Participants will collect and discuss ideas on the efficient use of GAO, how to optimize its applicability for chosing and evaluating sources in line with novel research questions and methodological approaches.

- (1) Seminar and group discussion focusing on the supervision of graduate thesis with GAO
- (2) Preparation of GAO manual with focus on keywords, tags, format and application

### **ASSESSMENT AND AIMS**

5 or 7,5\* ECTS

After completing GAO-S participants will have

- acquired skills in processing digital sources in different languages and archives
- identified appropriate research topics and key concepts for research in History and related subjects in Global Humanities
- understood how to use GAO in supervision and teaching, as well as in their research
- contributed to formulating step-by-step instructions and user tips for future users of GAO (GAO manual)
- reflected critically on the chances and challenges of Digital History
- deepened their awareness for more ethical and more democratic research in global history

\*Doctorate students who will participate in the development of a supervision manual for GAO (to be published on GAO with the students' own authorship) as part of their assessment are entitled to 7,5 ECTS.
